Turning to some other state issues...

31. The personal property tax paid by Michigan businesses on the value of their industrial and commercial machinery and equipment generates about \$1.27 billion a year statewide. About 60% of this tax revenue goes to the cities, villages and townships where the businesses are located and the other 40% goes to local public school districts. Since many states do not have a personal property tax, some people have argued that if Michigan eliminates this tax, it would provide an incentive for businesses to locate in the state and it would encourage businesses already in the state to invest in new machinery and equipment, which would create more jobs. Would you favor or oppose a proposal to totally eliminate the personal property tax on Michigan businesses?

If the personal property tax on businesses is repealed, it would eliminate about \$770 million in revenue that currently goes to cities, villages and townships, and about \$500 million that currently funds local public school districts. Elimination of this local revenue source could result in major cuts in police and fire protection, as well as other local government services such as street repair and snow removal. It could also require many local public school districts to lay off teachers and support staff, as well as cut existing programs to balance their budgets. On another topic,

34. The state of Michigan, and the Province of Ontario, have been planning a new bridge between the U.S. and Canada that would originate in the Del Ray neighborhood in southwest Detroit. Michigan's share of the project would be paid for by the Canadian government; an amount that would trigger the necessary matching funds from the federal government to complete the project. A private company would operate the structure and assume the financial risk for operational losses.

At the same time, the private owner of the Ambassador Bridge is planning to build a twin span next to the existing Ambassador Bridge that would be built with private funds.

Supporters of the public bridge believe infrastructure such as cross-border bridges provide the most reliability and security when owned and managed by government units. Supporters of building a twin span next to the Ambassador Bridge say that the region has been served by a privately owned bridge in the past and can continue to be served by a privately owned project.
