On a more regional topic, representatives from Wayne, Oakland and Macomb counties, the City of Detroit and the Governor's office reached an agreement to restructure the Detroit Water & Sewerage Department by creating a 6-member governing body called the Great Lakes Water Authority. The six members of the new governing body will be made up of 2 members representing the City of Detroit, 1 member each from Wayne, Oakland and Macomb Counties, appointed by the respective county executives and 1 member appointed by the Governor. Under the agreement, any major decisions affecting water and sewer service, including changes in rates and fees, will require a super majority of five-out of six votes.
